A good communication connection in road traffic is the depicted by two regional roads leading through the center of our municipality and connecting us with Prnjavor, Teslić, Doboj, Tešanj and Derventa, and even further towards international traffic corridors of EU countries and wider. During the next year the regional highway P474 will be re-constructed in full to give quality answer to the needs of transport of passengers and goods, with the goal of motivating the economic activities in this area. We should not forget a significant competitive advantage of this area represents the complete energetic stability in a sense of servicing the needs of all potential investors without any limitations. All of that is enabled by installing the thermal power plant "Termoelektrana Stanari" and accessibility of electro-net with built electro line and with substations, by which it is enabled a reliable and quality sturdy energy supply.

At the end, keeping in mind, that we need new investors, the message I could pass to all the good willed people, potential investors and representatives of the business community, says:

The Stanari municipality is located in the north-eastern part of the Republic of Srpska, between 17°83' eastern geographical length and 17°50' northern geographical width and borders with the towns of Doboj, Derventa, Prnjavor and Teslić. Doboj town is the closest center with which Stanari municipality is strongly connected both economically and in the area of social development. Stanari municipality is going to be connected with administrative headquarters of the Republic of Srpska and the border crossing "Gradiška", between the BiH and Croatia, during 2018 by the highway Doboj-Banjaluka-Gradiška.

Economy of the Stanari municipality is tightly related to the history of coal mining and energetics in this area together with important roads and railways leading through the Municipality territory.

The Stanari territory, where 100 years ago began the exploitation of coal and through which 60 years ago went the railway Banjaluka-Doboj, surely in the greatest measure has become recognizable by those two above mentioned elements of economical, as well as entire social development of this area. The coal exploitation in Stanari began in 1948, at the open coal mine "Raškovac", as the underground exploitation began in 1955 in the northern part of the mining basin. In the southern part of the basin the excavations were carried out from 1974 to 1980, in the coal seam "Ostružnja". Starting from 1974, coal excavation has been mostly concentrated on surface mines, yet before that it was presented also the underground exploitation. Today, the surface mine "Raškovac" is the only one in use, since the mine "Ostružnja" is currently out of use.

Stanari lignite is of high quality it contains low levels of sulfur and ash, as well as acceptable heat value for lignite coals.



In 2004 the Government of the Republic of Srpska announced an international tender in order to find a private partner for the Lignite mine "Stanari". In that year, the Mine was bought by the company "EFT" which started with the investment cycles which have resulted with the establishment of the Thermal Power Plant "Stanari" together with increasing of coal production to 2.5 mil. tons and installed power in electricity production of 300 MW.

As accompanying raw material in coal reserve, there are many bentonite in a form of interlayered clay, with estimated reserves of approximately 10 mil. tons, together with big supplies of sand and gravel.

Besides the above mentioned capacities for development of energetics and coal mining, on the local level, there are presumptions of wood processing, agricultural and crafts sector. According to the latest data, there are 63 business entities on the territory of the Municipality, from which direct foreign come from EU countries, and export of the domestic products is realized to the markets of Austria, Germany, Switzerland, Slovenia, Croatia, etc.

The local economy is depicted through coal mining and energetics, wood processing, agriculture and small businesses.

Forests occupy 53% of the total area of the Stanari municipality territory, while 39% of the surface is characterized as agricultural land. All of the mentioned create significant presumptions for the development of agriculture and wood processing.

ПОЉОПРИВРЕДА

The total area of agricultural land is 6.084,6 ha or approximately, 39% of the total space of Stanari municipality. All arable land and gardens, orchards, pastures and meadows are in private possession. The area of Stanari Municipality, with the elevation of 138 to 343 m, passes ecological requirements that suit the agricultural development. The moderate continental climate together with suitable configuration of the land, open the condition for the development of the agricultural production. The traffic acts as an important factor promotion of the agricultural production, as well as the commerce between the agricultural producer and the market. The traffic connection of the agricultural land within the Municipality is on the satisfying level, together with the wider surrounding.



It is important to point out that on the area of Stanari municipality, there is a great interest for agricultural production, so we have 4.5ha under plantation of hazelnut, 3,2ha under plantation of raspberries, 1,3ha under plantation of strawberries, 1ha under plantation of aronia, and during the latest time period there have been 2,2ha under plantation of cucumbers, so it could be said that the green house production is developing, covering 1,4ha of the land surface.




The unemployment rate was 39%, by the rate of economic activity from 41% in 2015.

The basic points of the development of infrastructure are :

- A good road connection with the regional centers (highway Banja Luka Doboj)
- A developed railway in the segment of transport of passengers and goods
- An excellent electro-energy infrastructure
- A good telecommunication infrastructure, coordinated with the needed standards

Transport infrastructure

The main roads in the area of the Stanari municipality are : the regional road Doboj-Prnjavor, P474, of 9.13 km in length, Prnjavor-Jelah P474, of 19.5 km in length and Tedin Han-Teslić P473, of 2.1 km in length (the given data are related on the road parts leading through the Stanari municipality) There are totally 111 km of asphalted roads of different categories. The road network is in a good shape. A part of the highway Doboj-Banja Luka borders between Stanari and Derventa municipalities.

Electricity infrastructure

The area of the Stanari municipality is supplied by electric power from the Substation 110/35 kV, 10MVA and Substation 400/110 kV " Stanari", 300 MVA. The installed capacity in the Substation 400/110kV meets all the needs of municipal development, counting on planned increasing of load of 2% annually. The Thermal power plant built in Stanari indicates a long term favorable perspective of the energetics development.



Telecommunication infrastructure

There are two switchboards in the area of the Stanari municipality, one of which is a digital ATC with 1440 numbers, and the other is an analog ATC with 900 numbers and an analog ATC with 240 numbers in Dragalovci. The area of the Municipality connected by optical and TK cables.

Water supply system

There is a water supply system network in the Stanari municipality that supplies the inhabited place Stanari center. The system is supplied with water from a well of 60m in depth , with a capacity of 400 m3 , currently supplying 400 users. While in other local communities, the water supply mostly comes out from the individual wells. The residents of Cerovica and Radnja Donja, together with Vitkovci (Teslič municipality), are supplied through private water supply systems. The industrial and economic capacities are supplied by technological water from their own wells and water supplies. The total length of the water supply network in the area of the Stanari municipality is 45km. 847 households are connected to the water supply network. There are big losses of water distribution because of frazzle and thet is why for the upcoming period of time it has been planned a building up of a new water supply network which would meet the needs of all residents of the Stanari municipality.



Sewage system

The sewage network does not exist in the area of the municipality and it is consisted of individual septic tanks.

Handling of the solid waste

There is an organized system of gathering of the solid waste.

Public lightning

About 10% of the Stanari municipality population is covered by the public lightning in the urban area where the important business entities of the Municipality are located.

Customs fees

The customs system in BiH is regulated by several autonomous and international regulations and is applied uniquely on BiH territory. The Law on BiH customs regulates the policy of the basic elements of the system for customs protection of the BiH economy, rights and obligations of all subjects in customs procedures of goods and passengers. There are regulated customs territory, customs line, customs border belt, customs control, the customs clearance procedure of goods and other institutes that regulate system of custom protection.

Customs tariff contains the range of rates from 0 - 15%. Customs regulations are carried out uniquely on the BiH territory. The customs clearance of goods imported to customs territory of the BiH is carried out by the customs office to which the goods are reported for the customs clearance. There are four regional centers in the BiH: Customs office Banjaluka, Customs office Sarajevo, Customs

office Tuzla and Customs office Mostar.

By the signing of the Agreement on Stabilization and Association, it is enabled the free export of almost all goods which fulfill the standards of EU, and at the same time, the BiH market is opening for the goods from EU according to the dynamics agreed in annexes and protocols which are belonging parts of the Agreement. The BiH has signed Free Trade Agreement CEFTA with the following countries: Albania, Montenegro, Macedonia, Moldova, Serbia and UNMIK/Kosovo. By the CEFTA Agreement it has been replaced but also supplemented the existing agreements on trade with individuals countries from the region. By that, it is enabled a greater transparency and the rules of the game close to the EU standards, as well as the access to the market of approximately 30mil. people. Also, it has been signed the Free Trade Agreement with Turkey, the Preferential Trade Agreement with Iran, and the Free Trade Agreement with EFTA countries: Switzerland, Liechtenstein, Norway and Iceland.

Exemption from payment of customs duties

The foreign investors can be exempted from payment of import customs duties on the equipment put into free circulation which represents a deposit of a foreign person.

Export limits on equipment which is a part of foreign investments

The equipment which is imported to the BiH as a foreign investment must not be older than 10 years. It is needed to obtain a certificate of the competent body which proves that the equipment suits the standards of life environment protection and safety at work.

Notary services

Notary service is a public services performed by notaries as autonomous and independent officers. The public notary's task is to process, verify and confirm public documents and perform other tasks according to the law.

The introducing of the notary to the RS in 2008 is a significant contribution to the rule of law, safety of the legal work and legal transactions by the article 68, the law on notaries ("The RS Official Gazette" number 96/04, 74/05, 91/06, 37/07, 50/10, 78/11, and 20/14), there were regulated legal affairs for which it is obligated a notary processing of the documents. Legal affairs which require the notary document processing for their legal validity refer to:

- Legal affairs on regulation of the property relations between spouses, as well as persons living in a common law marriage

- Disposal of assets of minors and business incapable persons

- Legal affairs that promise some act of gift, except that the lack of notary form in this case is replenished by the execution of the promised act

- Legal affairs which subject is a transfer or acquisition of ownership or other real rights on real estate and

- Founding acts of companies

The legal affairs that are not subject to the notary processing are legal affairs that mutually conclude the Republic of Srpska and local governments, as well as the agreements among local governments, whose subject is acquiring of the ownership rights and other real rights on founding acts of companies, if the founder is the RS or a local government.

The obligations of the notary document processing can be predicted also in other cases, such as:

- The parties have right to demand notary document processing also for other legal affairs for which it is no predicted and obligatory notary document processing

The notaries have right on award and compensation for their work in height and in a manner arranged by the Regulation on determination of notary's awards and compensation in the RS. ("The RS Official Gazette", number 54/12, 103/13 and 6/17).

NOTARY AND LEGAL SERVICES

Legal services

By the Law on advocacy of the RS ("The RS Official Gazette", number 80/15) it is regulated legal services, the conditions of performing advocacy, forms of law practice, rights and obligations of the lawyers, associates for legal affairs and law clerks and organization and work of the Bar association of the RS.

The advocacy is independent and the custom autonomous service of giving of the legal help to physical and legal entities. In accordance to the Law on advocacy of the RS the prices of the legal services are determined by the tariff on awards and compensation of the costs for the work of advocacy in the RS ("The RS Official Gazette" number 68/05).

Membership fees in the Chamber of commerce

According to the Law on Foreign trade chamber, the tax payers are members of the Chamber, that means companies, banks, insurance companies and other legal entities, registered for the performing of the work with foreign countries of the territory of the BiH.

Monthly sum of the membership fee in the Chamber is limited on three average net salaries at the level of the BiH, they are as follows:

- Chamber of Commerce of the RS regulates the membership fee on annual level of 0,03 % on realized income in previous year;

- Foreign trade Chamber of the BiH regulates the membership fee of minimum 20KM monthly, that means, 0,1% of the total import.

Tax and property

- The Decision on height values of the real estate on the territory of the Stanari Municipality by zones for needs of determining of tax on real estate in 2017 – by this decision it is determined the height of tax of real estate on the territory of the Stanari municipality, by the zones in 2017

Fees for forests

- Forest and forest land user is due to pay fee for using of a forest and forest land in height of 20% of income realized by selling of forestry wood products (determined by prices in forest on the stump by the price list of the user) to the account of public revenue of the RS and a fee of 10% (determined by prices free on roadside for a specific calendar year) to the account of public revenue of the Stanari municipality.

Contributions and taxes on various bases - The fee for change of a change of use of the land – is payed in accordance with the Law on agricultural land ("The RS Official Gazette" number 93/06, 86/07. 14/10 and 5/12) and by the decision in assessment of cadastral income from the land on the territory of the RS ("The RS Official Gazette" number 28/13).

Municipal administrative taxes - The taxes are paid in accordance with Decision on municipal administrative taxes, ("The RS Official Gazette" number 1/15). By this Decision it is assessed the obligation of paying municipal administrative taxes for documents and acts in procedure in front of organs of administrative service of the Stanari municipality, public administration and companies and other organizations which carry out public authorizations, if it is by the Law or Municipal Decision trusted on solving in administrative matters on certain rights and obligations

Utility fees - Are paid in accordance to the Decision on utility fees ("Stanari municipality Official Gazette" number 1/15). By this Decision it is assessed the kind, height terms and method of the payment of the utility firm.

Height of annuities - Is paid in accordance to the Decision on utility fees ("Stanari municipality Official Gazette" number 1/15). By this Decision it is assessed conditions and the method of disposal of the town building land by the zones, base and benchmark for the calculation of the fee for development of the town building land and the annuity fee, method of payment of the fees, conditions for the building of the out buildings and the placement of the temporary facilities and devices, the method of the renting of the location conditions for felling of trees decorating of facades, as well as other issues of importance for landscaping and building on the Municipality's territory.

Incentives at the level of the Stanari municipality

Incentives at the level of the RS

To a taxpayer, who, on the territory of the RS, invests in equipment, plants and real estate for performing of the registered productive work in value greater than 50% of realized profit (tax base) of the current tax period of time, it lessens the obligation of the tax on profit by 30%.

Incentives at the level of BiH

In accordance to the Law on policy of the direct foreign investments in the BiH ("The BiH Official Gazette" number 17/98, 13/03, 48/10 and 22/15), the foreign investors are guaranteed the following:

- National treatment to the foreign investors which means that the foreign investors have the same rights and obligations as the BiH residents

- The foreign investors have the right for their investments, on the territory of the BiH to open accounts in any business in domestic or free convertible currency.

- The foreign investors will have the right to freely employ foreign citizens from abroad unless it is differently determined by the BiH laws on work and immigration.

- The foreign investors are protected from nationalization, expropriation, requisition and measures with similar effect. Such measures can be taken exclusively in public interest, according to the applicable laws and bylaws, with payment of appropriate compensation.

- The foreign investors have the same ownership rights over real estate as the legal entities of the BiH.

- The foreign investors have right on transfers abroad, freely and without delay in freely convertible currency, gains that are made as the result of their investments in the BiH. Rights and benefits given to the foreign investors and obligations which come out from the Law on policy on direct foreign investments, cannot be neither abolished nor nullified by coming into effect of subsequently passed laws and bylaws.

If such subsequently passed laws and bylaws are more favorable for foreign investors, they have the right to choose which one will be authoritative for their investments.

Customs benefits

Foreign investments will be exempt from customs and customs duties, except passenger vehicles, slot machines for fun and games of chance

For the use of customs benefit with the written application for exemption of payment of the import duties the benefit user, to customs authority competent to the place of the benefit user's seat, is submitting:

- Contract or other appropriate act on investment, upon which is imported equipment for which is asked the exemption of import duties

- The proof of registration of foreign investment at competent authority of the state

- Specification of the equipment by the tariff code and appointment of the Customs Tariff of the BiH, with labeling volumes and individual and total value, which is authenticated by the benefit's user

- Statement of the investment that the equipment is no older than 10 years

- Confirmation that the imported equipment meets the standards concerning the protection of the environment and other standards of work safety, issued by an institution or other competent authority for the area of that activity.

Customs Agency brings a decision within 15 days from the day of the submitting of the application.

Free zones

The free zones in the BiH are the part of customs territory of the BiH and have the status of a legal entity. According to the Law on free zones of the BiH, the founder of a free zone can be one or more domestic or foreign, legal or natural entity who are registered in the BiH. The Users of a free zone do not pay value-added tax and import duties equipment which is to be used for production. Investments in a free zone, the transfer of profit and the transfer of investments are free.

The establishment of a free zone is economically justified if on the basis of the attached study on economic justification of the established free zone and other submitted evidences, it could be estimated if the value of goods, which are exported from the free zone will cross at least 50% of total value of the manufactured goods that leave the free zone within a period of time of 12 months.

INSTITUTIONS AVAILABLE TO THE INVESTORS

Ministry of economic relations and regional co-operation (MEOPC)

Ministry of economic relations and regional co-operation (MEOPC) performs administrative and other professional activities, which among other things, aim to encourage the foreign investments and export, through following, analysis and proposing of measures for improvement of the legal framework for foreign investments, follow-up and analysis of the investment environment, co-ordination and initiating of activities for improvement of overall ambiance for foreign investments, professional support to foreign investors during the preparations and realization of the foreign investment, promoting of the investment potentials of the RS at home and abroad, co-operation and organizations on the BiH level (FIPA and other), international organizations and institutions, institutions of similar characteristics outside of the RS.

RS representations abroad

The RS representations abroad are formed with the aim of establishing of economic, scientific and technological, cultural, social, informative, educational, sport, and other co-operation with entities abroad.

The representations which are currently active are in: Serbia, Russia, Israel, USA, Austria, Greece, Germany, and there is an opening of the representation in preparation in Croatia.

RS Chamber of Commerce

RS Chamber of Commerce with Regional Chamber which make a unique Chamber system, works on establishing of economic ambience.

RS Chamber of Commerce with the Regional center in Doboj, lobbies for the key questions of influence for creating a more favorable business environment.

RS Investment-Development Bank (IRBRS)

RS Investment-Development Bank (IRBRS) is established with the aim to encourage investments and stimulate the development of the RS.

The activities of the IRBRS, primarily are focused on financing of the development projects of importance of the RS economy in connection with the increase of the employment, construction of the infrastructure facilities in the RS, export oriented production, the improvement of corporative governance and capital market, small and medium entrepreneurship, environmental protection, balanced regional development, improvement of agricultural production, residential and office building, effective carrying out of the privatization, restructuring of the companies in the context of privatization, encouraging of the production that reduces import dependence, international promotion of investment possibilities in the RS.

Republic Agency for small and medium companies (PAPC)

Republic agency for small and medium companies is a generator of the entire system of support to the development of small and medium companies. Through numerous projects and preparations of support to the local economic development, the development of the small and the medium companies and entrepreneurships, its aim is the increase of participation of the small and the medium companies in the RS economy, the increase of technological development, competitiveness and opening of the new market for the small and the medium companies, the increase of number in business entities and newly employed workers in these companies, establishing of the regional co-operation with neighboring countries in order of developing of the experience, etc. The business zone "Thermal Power Plant" represents a place of future economic development of the Stanari municipality and the home of new investments. The business zone is in final phase of preparation of the terrain on the surface of 3.3ha with 9 parcels meant for the investors, for which some, of whom have already expressed the interest.
